

THIRD COUNSELLING FOR B.A.LL.B., DEGREE COURSE ON 07.10.2024


The third counselling for the two vacant/surrendered seats available for admission to the B.A.LL.B. (Five-Year Integrated Course) in Andaman Law College will be held **on 07.10.2024 (Monday) at 10:00 AM in the College Auditorium.** Interested candidates whose name appeared in the final merit list are hereby directed to appear in person with all educational qualification certificates/testimonials requested for the counselling session on the date and time as specified above. The unfilled seats will be allotted in the order of Category-V (General Merit) only based on merit, starting from the cutoff marks of 72.4% (Sl. No. 384) established in the second counselling held on 10.09.2024. Further, if any seats still remain vacant after the initial allotment, the same will be offered/allotted to fresh eligible candidates present at time of counselling, according to their merit. Therefore, fresh eligible candidates those who are interested in the allotment of the vacant/surrendered seats are also requested to be present on the above date of counselling session with all original testimonials.
