
**Revised Provisional Merit list of candidates who have applied for allotment of BDS, BAMS, BHMS, MBBS (Malayalee Origin) & BAMS (Malayalee Origin) courses reserved in mainland institutions for the students of A & N Islands for the academic session 2024-25**

In compliance to the direction of the Hon'ble Supreme Court of India in W.P (Civil) No. 335/2024 Order dated 23.07.2024, the National Testing Agency has issued Re-revised Result/ NTA Score/ Rank of the National Eligibility cum Entrance Test NEET (UG)-2024. Accordingly, the Higher Education Branch (D-IV Section), Secretariat, Port Blair vide press note published in the print media as well as in the electronic media requested the interested and eligible candidates who have applied for allotment/nomination of BDS, BAMS, BHMS, MBBS (Malayalee Origin) and BAMS (Malayalee Origin) courses to submit the Re-revised Result/ NTA Score/ Rank of NEET (UG)-2024.

No claims/objections will be entertained or accepted after the expiry of the stipulated date and time as specified above.

The provisional and final merit list of BDS, BAMS, BHMS, MBBS (Malayalee Origin) & BAMS (Malayalee Origin) courses which was published earlier in the website shall be treated as cancelled.


