Submission of Re-revised Result/ NTA Score/ Rank of the National Eligibility cum Entrance Test NEET (UG)-2024

It is brought to the notice of all concerned candidates who have applied for allotment/nomination to BDS, BAMS, BHMS, MBBS (Malayalee Origin) and BAMS (Malayalee Origin) courses reserved at mainland institutions for the students of A&N Islands for the academic session 2024-25 are informed that in compliance to the direction of the Hon'ble Supreme Court of India in W.P (Civil) No. 335/2024 Order dated 23.07.2024, the National Testing Agency has issued Re-revised Result/ NTA Score/ Rank of the National Eligibility cum Entrance Test NEET (UG)-2024 on 26.07.2024.

Accordingly, the final merit list of BDS, BAMS, BHMS, MBBS (Malayalee Origin) and BAMS (Malayalee Origin) courses is required to be revised in terms of the re-revised Result/ NTA Score/ Rank of the National Eligibility cum Entrance Test NEET (UG)-2024 declared by NTA vide Press Release dated 26.07.2024.
